CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2001-17

Being a by-law to authorize the construction of sewers and watermains on Alma and Victoria Streets and the signing of an agreement between the Corporation of the Town of Amherstburg and D'Amore Construction (Windsor) Ltd.

WHEREAS Council is desirous of replacing a watermain and constructing a storm sewer on portions of Victoria Street and also in providing an 8" waterline on Alma Street from Meloche Road to the 4th Concession South;

AND WHEREAS certain property owners have petitioned the Town for a sanitary sewer on a portion of Alma Street;

AND WHEREAS Hanna Ghobrial and Spencer have been engaged by the Town to prepare the necessary specifications to tender the projects and to obtain the necessary approvals;

AND WHEREAS the petitioners for the sanitary sewer on Alma Street have agreed to pay 100% of the costs including engineering of the Alma Street sanitary sewer project;

AND WHEREAS the construction costs including engineering for the Alma Street watermain will be charged to the eligible properties on the north side of Alma between Meloche Road and the 4th Concession South on a per foot frontage basis;

AND WHEREAS the tendering process has been completed and it is the recommendation of the engineer to award the tender to D'Amore Construction (Windsor) Ltd. at a cost of <u>\$604,315.50</u> plus GST.

NOW THEREFORE THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

- 1. That the Town proceed with the construction of the Alma Street and Victoria Street sewer and watermain projects in accordance with the specifications prepared by Hanna Ghobrial & Spencer.
- 2. That the contract for the projects be awarded to D'Amore Construction (Windsor) Ltd. in the amount of <u>\$604,315.50</u> plus GST.
- 3. That the Alma Street sanitary sewer project be paid by the petitioning landowners.
- 4. That the cost of the watermain project, including engineering fees, on Alma Street between Meloche Road and 4th Concession South be charged to eligible properties on a per foot frontage basis on the north side of Alma Street between Meloche Road and 4th Concession South at the time of application for water service.
- 5. That the properties on the north side of Alma Street between Meloche Road and 4th Concession South become part of the Amherstburg Water Service Area.
- 6. That the Mayor and Clerk be authorized to sign the contract with D'Amore Construction (Windsor) Ltd. and apply the corporate seal thereto.
- 7. That this By-Law shall come into force and take effect immediately upon passing thereof.

Read, first, second and third time and finally passed this 9th day of April, 2001.
