## **CORPORATION OF THE TOWN OF AMHERSTBURG**

## **BY-LAW NO. 2003-101**

Being a by-law authorizing the borrowing of money by way of temporary advances to meet expenditures made in connection with a certain project.

**WHEREAS** the Council of the Corporation of the Town of Amherstburg has authorized the purchase of various properties for Parks & Recreations purposes at an estimated cost of \$553,403.35.

## THEREFORE, THE COUNCIL OF THE MUNICIPALITY ENACTS AS FOLLOWS:

- 1. The Head and the Treasurer are hereby authorized on behalf of the Municipality to borrow by way of temporary advances from time to time from **Canadian Imperial Bank** of **Commerce ("CIBC")** a sum of sums not exceeding in the aggregate \$553,403.35 to meet expenditures made in connection with the Project and to give on behalf of the Municipality to CIBC a promissory note or notes sealed with the corporate seal and signed by the Head and Treasurer for the moneys so borrowed plus interest at such rate and for such term as may be agree upon from time to time with CIBC; all in accordance with the Agreement/Demand Installment loan; the amount of the installment of principal and interest payable in that year as set forth in Schedule "A" hereunto annexed;
- 2. All sums borrowed under this By-law, as well as all other sums borrowed in this year and in previous years from CIBC for any or all of the purposes mentioned in the Ontario Municipal Act, plus interest, shall be a charge upon the whole of the revenues of the Municipality for the current year and for all proceeding years as when such revenues are received;
- 3. The Treasurer is hereby authorized and directed to apply in payment of all sums borrowed pursuant to this By-law, plus interest, all of the moneys hereafter collected or received either on account or realized in respect of taxes levied for the current year and preceding years or from any other source which may lawfully be applied for such purpose;
- 4. The Treasurer is hereby authorized and directed to furnish to CIBC a certified copy of the Order.
