AND WHEREAS land has been transferred to the Town for the widening of Fryer Street described as follows:

Area 426 sq m

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg enacts as follows:

- THAT the lands described as 12R-23252, Parts 3 and 4, with an area of 426 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby established as a public roadway, to be named Fryer Street.
- 2. THAT this By-law shall come into force and take effect immediately upon the final passing thereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.
