Mayor Hurst presented a Council Resolution to Daniel Fox congratulating him on initiating the idea of having the "Why The Mayor Is Important" contest.

Mr. Mike Kosyk addressed Council on various drainage related problems.

Boundary Markers moved by Contractor on Drainage Project

Mr. Kosyk explained that the contractor had removed the boundary marker during construction and had relocated it in the wrong location. Mr. DiCiocco, the Drainage Superintendent, explained that he would have the contractor relocate the marker to its original location.

Grondin Drain

Mr. Kosyk handed out a copy of an appeal to the Tribunal dated September 24, 1997 in regard to the Grondin Drain Project. He advised that he had agreed that he would pay only \$1,700.00 and the project proceeded on that understanding. Mr. DiCiocco explained that Mr. Kosyk's estimated assessment was approximately \$2,700.00 and the Ministry of Agriculture & Food grant would reduce that by 1/3. The project is within the estimated amounts.

Ditch between 2nd Conc. and Essex Terminal Railroad (Portion of Grondin Drain)

This portion of the Grondin Drain was not included in the original report for cleaning, however, now this section needs to be cleaned to make the drain work properly. This is being done under maintenance and Mr. Kosyk wants to know what portion of the cost will be assigned to him. Mr. DiCiocco roughly estimated the total cost to be about \$600.00 with this amount to be distributed among all affected landowners. Mr. Kosyk's cost was not known at this time. Mr. Kosyk felt that the estimate of \$600.00 for the work was low. Mr. DiCiocco explained that only a minor cleanout was required between the 2nd Concession and the railroad tracks. The culvert under the 2nd Concession needs to be flushed. He feels that once this is done the Drain should drain well, however, due to the flat grade between the 2nd Concession and the railroad, and the residential use of the drain, there may be a small amount of water in the drain.

After discussion, the Administration was directed to obtain the files on the Grondin Drain and invite Mr. Kosyk to a meeting to discuss his concerns as soon as possible.

Mr. Dennis deGraff of 254 Lakewood Drive addressed Council on the necessity of installing sanitary sewers in the Erie Beach area and requested confirmation on when the work would be done.

Mayor Hurst thanked Mr. deGraff for presenting his concerns to Council. Council is actively pursuing a grant from the Province to partially finance the project. A meeting is being set up with the Ministry of the Environment to determine the status of the grant application. The Mayor emphasized the need and urgency of getting the project completed. There is a Public Open House for the project on Monday, June 15, 1998.
