It was explained that this meeting was called to hear the views and concerns of the Texas Road residents in relation to operation of home occupations and the raising of livestock. Jean Monteith explained that Texas Road is an example of an area that was rural but because of strip development it has become residential. The Town has made slight concessions for these areas in the Official Plan and this has also carried over to the proposed Zoning Bylaw somewhat.

Larger lots are condusive to residents wanting to do things on their properties such as the raising of livestock and home occupation type operations.

The residents present gave specific examples of what they saw as problem situations with their neighbors activities. The main concerns expressed were the raising of chickens and similar livestock and the parking of trucks on residential lots.

One resident expressed a need for sidewalks in the area and a traffic light at the corner of Texas Road and Highway 20.

The Planner, Jean Monteith after hearing the concerns of the residents stated that she would develop some policies for Council consideration.
