Approximately 16 residents of the 3rd Concession area were present to discuss the proposed sanitary sewer for the Third Concession from McLeod to Municipal # 3860. Mayor Hurst welcomed all present and asked the residents to indicate if they were in favour of sewers going down the street. After hearing that more information was required, the Mayor requested that Mr. Thomas review the project details with the residents. The Third Concession area in question could be serviced for approximately the same cost per property as the main project.

Questions arose as to the validity of the petition and that people had signed the petition without full knowledge of the project details. Also the question was raised whether or not it was mandatory to connect into the sewer. After much discussion, a consensus on the following action was reached.

Administration would send a letter to all those who had signed the petition explaining that if they wished to withdraw their name from the petition now that more information had been received, they would have that opportunity. As a bench mark, Council would use one of the provisions provided in the Local Improvement Act to determine if a petition is sufficient. That provision requires that the petition must be signed by 66 and 2/3rds % of the landowners which represent 50% of the value of the property to be assessed. The project would be commenced under the Municipal Act not the Local Improvement Act. Also, staff will check the rules on mandatory connection to the system.

There being no further business, the meeting adjourned.
