Whereas the Town of Amherstburg did submit a Letter of Intent to the Ontario Superbuild Corporation for Round One of the Sports Culture and Tourism Partnerships Initiative for a Waterfront Redevelopment Project; and

Whereas the Town has now been advised that it is eligible to proceed to the application stage; and

Whereas approximately 400 other projects have been invited to proceed to the application stage in an attempt to gain access to \$60 million of funding in Round One; and

Whereas the Town has been presented with many requests for projects and improvements to

recreational facilities, infrastructure, the waterfront, and other opportunities with the potential to improve economic development within the community; and

Whereas the Town is desirous of preparing a long term plan to accommodate the needs of the community while being fiscally responsible; and

Whereas simultaneously approving all of the projects for these competing interests would create a substantial financial hardship for the ratepayers of the Town.

Now therefore be it resolved:

- 1. That the Town advise the Ontario Superbuild Corporation that it will not be submitting an application to the SCTP Initiative in Round One.
- 2. That the Town commence a process to develop a long range plan to address the needs of the community.
- 3. That the Town accept the offer of Mr. John Laframboise to establish a volunteer committee of individuals to be known as the ACommittee for a Better Amherstburg@, to assist the Town in the preparation of a long range plan to include all aspects of recreation, infrastructure and opportunities to improve economic development, for the consideration of Council.
- 4. That the C.A.O. advise the Town within two weeks with regard to the proposed composition of the Committee for Council approval.
- 5. That the Committee investigate all avenues for partnering, development, and revenue generation in order for the Town to address the competing interests of many community groups.
- 6. That the Town be prepared to commit the sum of Seven Million Dollars to such a long range plan provided the same makes economic sense for the community.
- 7. That the Committee be requested to prepare a report for the consideration of Council no later than June 29, 2001.
