2. Schedule

The most recently submitted Lepera Schedule shows that the progress to date is approximately two weeks behind schedule. However, the contract is slightly less than 25% complete by the end of September and there are less than 40% of the available working days remaining. After lengthy discussion, it was agreed that Lepera would submit a revised schedule showing the order of events and the work items which are to be completed this calendar year. The Town advises Lepera that both Park Street and Kempt Street must be reconstructed this year, and that Sandwich Street must be reinstated as quickly as possible to ensure placement of surface asphalt this year.

14. Next Site Meeting

Site meetings will be convened every two weeks or as required. Site meetings will be conducted at the Public Services Building or the Town of Amherstburg. The next scheduled meeting will take place on 25 October 2007, at 2:00 p.m.

23. Asphalt Restoration-Sandwich Street

The asphalt restoration required on Sandwich Street is currently scheduled to be completed during the last two weeks of October, weather permitting.

Lepera

24. Complaints

Seven complaints have been received this period. A copy of these complaints and associated action undertaken is enclosed with these minutes. One complaint is associated with dust. Lepera to continue daily dust control and continue with the use of a brine solution for dust control. Two complaints pertain to stock piled granular material, both of these issues have been addressed. One complaint pertains to stone on the sidewalk, one due to litter within the excavation and two pertaining to restoration. The restoration complains must be reviewed at the conclusion of construction to ensure a satisfactory resolve.

39. Watermain Timing

All water related work is scheduled to be complete by 19 October 2007, weather permitting.

The site trailer has been provided with proper servicing as of this date.

42. Traffic Detour- Simcoe Street Road Closure

Lepera has requested Closing of Simcoe Street in order to expedite construction. The Town has requested that Lepera submit this proposal showing the affected area, anticipated duration, traffic detour proposed and any project cost implications associated with this request. Lepera to submit same to HGS for distribution to Town administration and the County of Essex requesting approval of same.

47. Amico Sewer Repair

Amico Contracting has scheduled to complete a repair to the relined trunk sanitary sewer on Dalhousie Street, immediately south of Park Street commencing on Monday 15 October 2007. The duration of this repair work will not be known until the problem area is exposed. HGS will advise Lepera of the anticipated duration once this information becomes available.

48. Municipal No. 176 Park Street

The resident at 176 Park Street advised HGS staff that their sanitary connection has a blockage. HGS staff advised the resident to contact a plumber to determine the cause of the problem as per Town policy.

49. Municipal No. 285 Sandwich Street South

The owners of 285 Sandwich Street South have advised that their toilet has been overflowing due to a blockage in the connection. Lepera and HGS staff to investigate this sewer reconnection today.
