5.2 Update on Contract "Inventory of Properties of Interest in the Core"

Discussion took place regarding the inventory of properties of interest in the core. Doris Gaspar has been contracted to assess all the properties within the core area. Once the information is compiled it will come to the committee and then go forth to Council. The inventory of interest properties is a good device as should a house be considered for designation by the property owner, much of the research has been done. It puts a 60-day moratorium on any request for demolition of the property. This information should be completed by February 1, 2013. Once adopted by Council it becomes a matter of public record. This list can be a working document to be added to at any time.

5.3 Update on Council motion of January 7, 2013 to protect properties of interest in the core.

Much discussion took place regarding the motion to protect properties prior to adoption of the district. This will be an ongoing issue – the Properties of Interest Inventory is one response.

5.4 Status and Timeline for approval of the heritage district

Administration is assessing the work that has been completed thus far. The committee needs to make the point to Council that the committee would like to see this move forward and completed shortly.

5.5 Use of social media for heritage in Amherstburg

M. Pillon will create a twitter account as well as a facebook page. There was also some discussion about a potential app for the smartphones.
