Dr. Coates addressed Council regarding Big Creek Watershed and environmentally affected illness. Dr. Coates noted that he served on the Big Creek Steering

Committee for 3 years. Dr. Coates requested that Council not accept the plan as it stands and that Council pass a motion to allow 3-4 months for additional studies to occur prior to the acceptance of the plan. A handout was given to Council and forms part of these minutes.

Tim Byrne, ERCA, addressed questions of Council. Mr. Byrne stated that the goals and objectives of ERCA have been completed with this study. He suggested that Council request the support of higher levels of government to perform the studies that Dr. Coates has requested.

10.1 Ray Tracey, CEO, Essex Power Corporation - Amherstburg's Role as Shareholder

Ray Tracey, CEO, Essex Power Corporation, addressed Council regarding Amherstburg's role as a shareholder. Mr. Tracey's PowerPoint presentation is attached and forms part of these minutes. Amherstburg represents 14% interest in the company.

The Town Solicitor requested a timeline from Mr. Tracey regarding providing financial information to the Town pertaining to its shares. The timeline provided by Mr. Tracey was approximately 5 days. The Town Solicitor requested clarification to Council regarding the payments from Essex Power Corporation. Mr. Tracey confirmed that profits were only \$1.6M and the additional \$2M was only a repayment to the Town over the course of 13 years.
