- b. WHEREAS in accordance with section 13.01 of the Lease Agreement, the Tenants are monthly tenants only subject in all respects to the provisions of the Lease Agreement, except for the following sections 1.02 (Term), section 1.03 (Option to Renew) and section 1.04 (Tenant's Right of First Refusal).
- c. TAKE NOTICE that the Tenants continued occupancy of the Property shall be as monthly tenants with a monthly rental payment of \$372.48 by the Tenants to the Landlord, in addition to all other rents, charges and payments as required by the terms of the Lease Agreement.

 The said monthly rental payment shall be effective on the date for a period of one (1) year, and shall thereafter be determined by the Landlord.
