4.0 COURT OF REVISION

Open the Court of Revision

The Court of Revision was opened by The Chair.

Shane McVitty, Drainage Superintendent & Engineering Coordinator, provided a brief overview of the purpose of the Court of Revision, its procedures, and the nature by which appeals can be submitted according to the Drainage Act.

4.1 Appeals – 8th Concession Drain Drain South

Mr. Gerard Rood, P.Eng of Rood Engineering Inc. provided the Court of Revision with a brief overview of the project. No appeals were received.

The Chair asked if there was anyone in the gallery who would like to verbally appeal to the Court of Revision.

The Board heard from the following:

Mr. Jon Parks - 7631 Concession 7 S

 Mr. Parks requested clarification on the percentage of the costs for Bridge # 10.

Mr. Rood explained the total cost of Bridge 10 is estimated at \$17,785, of which \$7,452 is assessed to Mr. Parks, and \$7,132 is assessed to the County for the enclosure portion. The remainder of the cost is assessed as an outlet liability to upstream landowners.

• Mr. Parks asked if it was possible to move the location of Bridge 10 to help with farming operations.

After discussion with the Board Members, Town staff and the Engineer, it was determined that:

- The report will be referred back to the Engineer to make the necessary changes.
- Reconsideration of the report is required, followed by a 2nd sitting of the Court of Revision.
- An amendment to the provisionally adopted bylaw will be required.
