2. Councillor Prue asked for an update with respect to the ward report.

The Clerk advised that the report will be before Council for consideration at the June 22nd, 2020, Regular Council Meeting.

3. Councillor Prue asked for an update with respect to the 2019 year end report.

The Treasurer advised that he is finalizing the report with KPMG and it will be before Council for consideration in the next month or so.

4. Councillor Prue asked for an update with respect to the 4 way stop request at Cherrylawn and Pickering.

The Director of Engineering and Public Works advised that she is awaiting information from the engineer and it should be before Council for consideration at the June 8, 2020, Regular Council Meeting.

5. Councillor Prue asked if the letter was sent to the disbanded volunteer Emergency Information Group thanking them for their past service and contributions.

The Fire Chief advised he has reached out to the only known member of the group in order to get the names of the others in the group; however, he has not received a response. He advised that the letter is drafted but is unsure of who to send it to.

6. Councillor Prue asked if the interest on the water charges for the property at 1175 Concession 2N have been waived.

The Treasurer advised that he is calculating the final interest charges that are to be waived and a letter will be sent to the owner of the property this week.

NEW BUSINESS

 Deputy Mayor Meloche asked what is being done to get the Town back to normal operations; what is being done other than layoffs to mitigate budgetary deficits as a result of the COVID-19 pandemic; and, is there an estimate of the financial impact as its relates to the approved budget figures.

The Chief Administrative Officer advised that Administration is currently looking into the physical improvements, as recommended by the Health Unit, that are to be in place to safely re-open Town Hall, Public Works, the Gordon House, and

the Libro Centre. He advised that he anticipates a cost of approximately \$40 000 - \$50 000 to install physical barriers and enhanced security for entrances and an unknown cost for enhanced cleaning protocols once all facilities are re-opened. He further advised that, in addition to the layoffs, the summer students program and installation of the ice at the Libro Centre are on hold.

Councillor McArthur what the plan is for businesses to open back up in downtown Amherstburg and if closing the streets to allow for patios is an option.

The Chief Administrative Officer advised that a discussion is currently underway with the Tourism Department and the Amherstburg Chamber of Commerce with respect to downtown street closures; and further, a report regarding the feasibility of downtown street closures will be before Council for their consideration at the next Regular Meeting or a Special Meeting called by the Mayor if need be.

3. Councillor Simone asked for a timeline with respect to the start up of all committee and board meetings.

The Clerk advised that the Committee of Adjustment, the Drainage Board, and Special Council Meetings for Planning matters are currently being set up for electronic participation and meetings will be underway shortly. As for the remainder of the committees, the Clerk's Department remains short-staffed due to the COVID-19 pandemic; however, the next committee to be set up for electronic participation will be the Economic Development Advisory Committee.

 Councillor Simone asked about the possibility of a 4-way stop at Texas and Concession 2 N and also the possibility of traffic lights at Simcoe and Meloche.

The Director of Engineering and Public advised that Texas and Concession 2N would be a County decision and a study would have to be requested. The Mayor advised that he will bring up the issue to County Council.

The Director of Engineering and Public Works advised that a budget paper was issued in the 2020 budget which outlined the cost for traffic lights at Simcoe and Meloche; however, there no further direction was provided at that time.

Councillor Simone asked that the traffic lights be added to the 2021 budget for discussion.

5. Councillor McArthur asked for a timeline with respect to Bell Fibre installation in McGregor and in the downtown core.

The Chief Administrative Officer advised that he is waiting on information from Bell for proposals for the downtown core and it will be brought to Council once received.

Councillor McArthur advised that the Essex side on Walker Road has their hanging flowers baskets up and asked when the Town is putting up hanging baskets up its side of the street.

The Chief Administrative Officer advised that it will be completed sometime next week. The Director of Parks, Facilities, Recreation, and Culture further advised that summer students are tasked with the hanging basket program; however, students have not been hired as of yet due to the COVID-19 pandemic and h the Parks staff will be tasked with hanging the baskets.

Deputy Mayor Meloche asked that the flowers and plants in the large planters along the Town's side of Walker Road be arranged so that they don't obstruct sightlines for drivers turning onto Walker Road.

 Councillor McArthur asked if the fence that is blocking off the designated fishing area at the Kings Navy Yard Park was staying up during the Silver Bass run.

The Director of Parks, Facilities, Recreation, and Culture advised that, in light of the COVID-19 pandemic and the physical distancing requirements, there is no intention of taking the fence down. He further advised that fishing is currently prohibited in the Kings Navy Yard Park and the designated area is not being expanded to accommodate the physical distancing requirements.
