NEW BUSINESS

 Councillor McArthur advised that there were news stories with respect to the logistical issues experienced at the drive-thru Santa Claus Parade in Kingsville and asked if there was a plan to ensure that the parade is seamless in Amherstburg.

The Director of Parks, Facilities, Recreation and Culture advised that Administration has recommendations for the Windsor Parade Corporation as a result of the issues that occurred in Kingsville and he is meeting with Corporation representatives tomorrow. He further advised that the plan will be communicated after that meeting.

3. Councillor Courtney asked what would happen if Ontario Community Infrastructure Funding (OCIF) funding were to be suddenly approved by higher levels of government.

The Treasurer advised that at this time, there has been no indication that the Ontario government will be announcing OCIF funding. He further advised that if the municipality were fortunate enough to receive OCIF funding, a report would be brought to Council for consideration as where to dedicate those funds such as towards the completion of priority projects and/or placement of the funds into reserves.

5. Councillor McArthur advised that Council received an email with respect to kids being required to come dressed for hockey. He advised that some parents dress their kids in the parking lot because they can't fit into their car seat when fully dressed and this becomes problematic in severe weather. He asked if any accommodations could be made to allow kids to finish dressing somewhere indoors. The Director of Parks, Facilities, Recreation and Culture advised that he doesn't see an issue with allowing kids of certain age groups to finish dressing in the skate tying area.

6. Councillor Prue asked if it was possible to have a plan in the new year to have Committees/Boards continue on with their meetings via Zoom.

The Clerk advised that there are some accommodation requirements to consider for some members.

The Mayor advised that it is on-going with respect to figuring out how to reinstate Committee/Board meetings during the pandemic.

7. The Chief Administrative Officer advised that large crowds are visiting the River Lights and physical distancing is not being respected or adhered to. He advised that additional proactive measures are required to keep the community safe and Administration is recommending that By-law 2020-046, Face Covering By-law, be amended to include mandatory face coverings while visiting the outdoor River Lights.

The Director of Parks, Facilities, Recreation and Culture and the Manager of Licencing and Enforcement provided their observations from the past weekend.

The Manager of Licencing and Enforcement explained the proposed amendment to the by-law and advised that the amendment to the by-law would include the requirement of mandatory face coverings at Toddy Jones Park and the Kings Navy Yard Park between 5pm and 11pm.
